Message from your Mayor

Well summer is moving along and I hope all of you are enjoying the weather. The newsletter gives me an opportunity to bring you up-to-date on what the staff and council are working on. We just had our annual “Nite to Unite” on August 1 and the staff did a great job putting it together. There was some miscommunication between the Lions Club, St. Francis Area Chamber of Commerce, the St. Francis Ambassador Program and the city, so I will be working with all of them for next year’s event in order to have it take place in one location instead of two.

The new website will be coming online in September and I think you are really going to like it. You will be able to find answers to your questions much easier than before, most of the time within two clicks. There will also be a place to subscribe to alerts and notifications along with Municode so you can check on current building codes before you begin a project and much, much more (stay tuned).

Recently the city has joined with Independent School District 15 (ISD 15) in working with the Minnesota Department of Transportation (MnDOT) in order to get a stop light installed at the intersection of Pederson Drive and State Highway 47. The city started the talks and now with ISD 15 on board, hopefully this will help persuade MnDOT to go ahead with a change that has been long overdue for the safety of our children. We will keep you posted.

Our city planner is working on an ordinance allowing residents to have chickens. As soon as that is done and approved it will be posted on our new website.

Recently the state legislature approved a long awaited bonding bill that would give our city 8.9 million dollars in grant money toward our wastewater treatment facility. As of the printing of this newsletter, the city has not received those funds; however it has been allotted by the Minnesota Public Facilities Authority (MPFA) and we should be getting it shortly. Once the city has obtained this grant money, there will be a new rate study done in order to see if any adjustments can be made to these high rates. As I have mentioned to you in past newsletters and at city council meetings, the council, staff and I are looking into everything that is possible in order to get these rates reduced. I wish I could tell you it will be sooner than later but please know that it is a top priority for this council.

I would like to bring up a concern of mine about speeding on residential roads. This has been an ongoing problem on many of our streets and my main concern, as always, is the safety of our children and residents. The St. Francis Police Department recently purchased a radar gun along with a second digital data speed sign from their forfeiture fund. I have always said that “a sign is only as good as the enforcement behind it” and that is what the police department will be doing. So please slow down on these streets. There is a reason the signs are posted and that is to prevent accidents.

One more thing I would like to remind everyone is to check for water leaks from either your toilets, faucets or outside spigots. If you look at your

13 Reasons Why Property Taxes Go Up Or Down From Year To Year

- The market value of a property may change.
- The market value of other properties in your taxing district may change, shifting taxes from one property to another.
- The state general property tax may change.
- The city budget and levy may change.
- The county budget and levy may change.
- The school district's budget and levy may change.
- A special district's budget and levy may change.
- Special assessments may be added to your property tax bill.
- Voters may have approved a school, city, county or special district referendum.
- Federal and state mandates may have changed.
- Aid and revenue from the state and federal governments may have changed.
- The state legislature may have changed the portion of the tax base paid by different types of properties.
- Other state law changes may adjust the tax base.

Citizen Reminders from Your Public Works Staff

Just a friendly reminder to make sure your water softener is operating efficiently. As many of you know, when the Minnesota Pollution Control Agency renewed our wastewater permit in 2015, we were given a chloride limit; this is where we need your assistance. High chloride levels in wastewater come from the backwashing cycle of your home water softener. If the softener is backwashing more than it should, it will cause higher levels of chloride in the waste stream. Please make sure that your softener is set to soften water with 13-14 grains per gallon or 230 Mg/L of hardness. You will use less water, which saves you money and helps the city achieve its chloride limit.

In the last couple of months, our city staff has had to pull lift station pumps more than usual due to plugging. This



can lead to an added expense for the city and potentially the homeowner. Please make sure that you are flushing only human waste and toilet paper. We are finding more disposable wipes and clothing that will not dissolve and will plug pumps. This leads to reduced pumping and more maintenance cost. This problem could potentially cause a backup of wastewater into homes causing an unwanted expense to the homeowner and to the city. With your assistance, we can correct this issue. Thank you.

Bus Stop Safety Please Watch for Children

- With school starting soon, drivers should be aware of children walking to and from the bus stop, as well as getting on and off the school buses.
- Slow down.
- The law requires vehicles to stop at least 20 feet from a school bus that is displaying its flashing lights and the stop arm is out.
- Fines are expected to increase this year for drivers who violate this law, anywhere from \$300 to \$500.
- A recent survey showed that 2,621 bus drivers counted 530 stop arm violations in one day.



St. Francis— Comprehensive Plan Public Meeting October 26

Ever wonder what role you have in shaping the city you live in? Every 10 years St. Francis is required to complete a Comprehensive Plan and submit it to the state. Every resident has the ability to provide input into one of the largest planning documents completed to assist in the development of the Comprehensive Plan. This plan guides city growth, redevelopment, infrastructure and the overall progress of the future of the city. We depend on the input from residents to identify what we are doing well, what we could do better and what you would like to see in the future. The city held one public event and asked for input on a survey. Now we are ready to move it to the next level. Join us for a public meeting to discuss what we have learned so far and continue to provide input into the future of the city.

Wastewater Treatment Facility

As you know, the new wastewater treatment facility went online in April. The city is pleased to announce that the new facility has successfully met all of its required effluent limits. This includes phosphorus and ammonia nitrogen, which the old treatment facility was unable to remove to acceptable levels. Both of those components can cause severe degradation of the receiving waters including rivers, lakes and streams. Phosphorus can lead to unsightly algae blooms, which has a negative effect on fish and other aquatic life. The other component, ammonia nitrogen, is a toxin that is harmful to aquatic species. The facility has also performed really well in removing other pollutants that we are required to remove. The Minnesota Pollution Control Administration will be onsite for final inspection within the coming weeks, to make sure the facility is performing as intended.

So what's left to do? Crews are finishing landscaping around the facility. This includes the site grading and installation of the irrigation system. A neat tidbit on the irrigation system is that the city will use treated effluent for the water supply; this is called reuse water. Reuse water is treated effluent that has been treated to meet a more stringent limit that allows the city to use it for irrigating. The blacktop has been laid around the facility. Electricians are working on a few minor systems. The city is currently still on track for substantial completion in September.

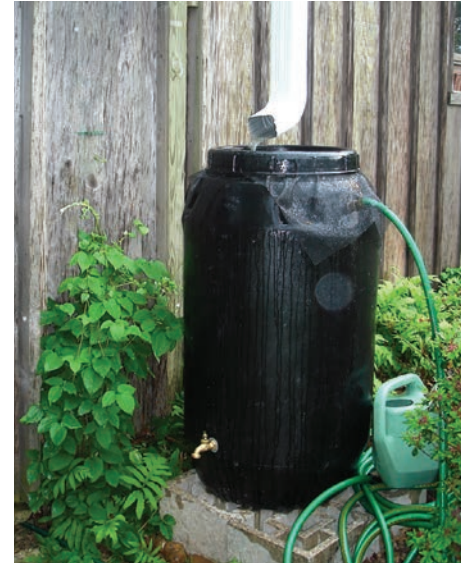

Rain Barrel Basics

Winter might not be an ideal time to start thinking about backyard gardening for green thumb enthusiasts, but it is a great time to get a jump start on water conservation efforts by setting up a rain barrel at your home.



A rain barrel is any type of container used to catch water flowing from a downspout. Rain barrels reduce the amount of stormwater runoff by collecting roof runoff and storing the rainwater for future use. By reducing stormwater runoff, we are also reducing the pollution that goes into our waterways.

Why use rain barrels?

- Save money
- Conserve water
- Rainwater is naturally soft
- Improve the health of lawns and gardens
- Stormwater management/erosion control

How does it work?

- Select a location to place your rain barrel, such as under a gutter or drain spout.
- Choose a rain barrel that fits your storage and aesthetic needs. Rain barrels come in a wide array of sizes and colors.
- Use with a soaker hose around trees, shrubs, gardens and plantings or use it to fill up a watering can for potted plants.
- Do not use rain water for human or pet consumption.

When can I use the rain water?

With many cities enforcing watering bans, rain water can be applied anytime and is naturally soft, devoid of minerals, chlorine, fluoride and other chemicals making it great for plants, lawns and gardens. Rain water cannot be used for human or animal consumption.

October 9-15 is Fire Prevention week; look for our firefighters in the elementary school teaching fire safety and prevention to our students.

Fall, football and Thanksgiving are just around the corner. Fall is also the busiest time of year for fire departments. This is largely caused by the home heating

season. Please take a minute to read the following tips provided by the National Fire Protection Association in regards to home heating concerns.

Heating equipment is a leading cause of home fire deaths. Half of home heating equipment fires are reported during the months of December, January and February. Some simple steps can prevent most heating-related fires from happening.

- Keep anything that can burn at least three feet away from heating equipment, like the furnace, fireplace, wood stove or portable space heater.
- Have a three-foot “kid-free zone” around open fires and space heaters.
- Never use your oven to heat your home.
- Have a qualified professional install stationary space heating equipment, water heaters or central heating equipment according to the local codes and manufacturer’s instructions.
- Have heating equipment and chimneys cleaned and inspected every year by a qualified professional.
- Remember to turn portable heaters off when leaving the room or going to bed.
- Always use the right kind of fuel, specified by the manufacturer, for fuel burning space heaters.
- Make sure the fireplace has a sturdy screen to stop sparks from flying into the room. Ashes should be cool before putting them in a metal container. Keep the container a safe distance away from your home.
- Test smoke alarms at least once a month.

School Year Safety Tips

The summer is coming to a close and back-to-school time is upon us. The St. Francis Police Department would like to give everyone the following safety tips for the new school year:

- Students that are riding their bikes to school should make sure to use a bike lock.
- Please have your child keep their helmet in their locker.
- When crossing Hwy. 47, please inform your child to use the crosswalk located at Pederson Drive and Hwy. 47 and to make sure traffic is stopped before crossing.
- When at the crosswalk, please encourage your child to push the button to activate the cross-walk flashing lights. This gives motorists a warning that the crosswalk is being used and to yield to all pedestrians.

- For students driving to school, please avoid keeping valuables in their vehicle.
- School buses mean children. Be aware of frequent stops and the flashing stop arms when buses are picking up and dropping off.
- Allow yourself extra time when traveling before and after school to account for the increased amount of traffic that we will encounter with school being back in session.

The safety of our community and our children is very important to us. By following these tips, you will assist the police department in making sure that everyone has a safe and successful school year.

Also, please be aware of the lowered speed limit on Pederson Drive which is now 35 MPH.

Gun Safety With Eddie Eagle

The Eddie Eagle class is returning for children who are currently in elementary school. Just as Smokey Bear teaches children not to play with matchbooks, Eddie Eagle teaches them not to play with firearms with a simple, memorable four-part plan:

- If you see a gun: STOP!
- Don't touch
- Leave the area
- Tell an adult



Whether or not a particular family owns firearms, chances are neighbors, friends,

and relatives do. Did you know that officials estimate there are over 200 million firearms in the United States? Studies suggest they're kept in approximately half of all households. This makes it likely that children will encounter a firearm at some point, so make sure they're informed.

The classes will be held on Thursday, November 2 at St. Francis Police Department, 4058 St. Francis Blvd. NW, St. Francis. There are two age groups, kindergartners-2nd grade at 4:30 p.m. and 3rd-5th graders at 6:00 p.m.
